HOUSES UNDER PMAY

No. 158. SHRI DUSHYANT CHAUTALA:

Will the Minister of HOUSING AND URBAN POVERTY ALLEVIATION be pleased to state:

(a) whether the Government had planned construction of 4.25 lakh houses for Economically Weaker Sections (EWS) in 227 cities in 11 States under Prime Minister's Awas Yojana (PMAY) during the current financial year ending March 2016;

(b) if so, the details thereof and the total number of houses constructed, State-wise including the State of Haryana till now;

(c) whether the Government has also planned to increase the number of beneficiaries under PMAY in future; and

(d) if so, the details thereof and the follow up actions proposed by the Government in this regard?

(a) & (b): Under the Pradhan Mantri Awas Yojana-Housing for All (Urban) Mission, launched on 25.6.2015, this Ministry has so far sanctioned Central Grant of Rs. 7,545.65 crores for undertaking 746

projects for construction of 5,08,902 houses for Economically Weaker Section (EWS) category in 544 cities of 13 States. State-wise details are at Annexure-I. No project proposals under the Mission have so far been received from the State of Haryana.

(c) & (d) The Mission aims to provide assistance to States/UTs in addressing the housing requirement of the slum dwellers and urban poor with the housing shortage estimated at 2 crore; exact scope will, however, emerge after demand assessment by all States/Cities.
